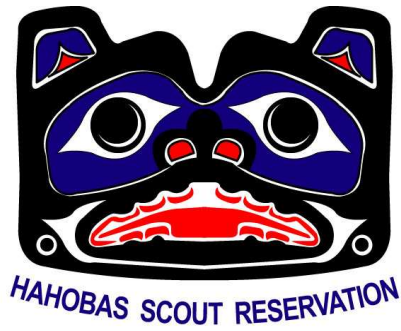

IMPORTANT PAYMENT SCHEDULE **INFORMATION FOR YOUR UNIT**

BOY SCOUTS OF AMERICA **CAMP HAHOBAS** **2011 Campsite Reservation**

- Immediately:** Fill out and submit this Reservation Form to your local Pacific Harbors Council Office with a \$100 Campsite deposit. A reservation is only made after the paperwork and Deposit are received at the Council Office. This Deposit is **NON-REFUNDABLE** but is transferable towards a future Campsite Reservation Deposit.
- March 1, 2011:** The first Camp Installment of \$100 per Youth and your Unit's Attendance Roster is due. If no installment is received by this date, you will forfeit your Campsite Reservation and we may assign your campsite to another unit. This Installment is **NON-REFUNDABLE**, but transferable to another youth's initial deposit in your unit. It may not be transferred to pay the 2nd 1/2 of a youth's fees.
- Early March:** Scoutmaster Handbooks for the 2011 Summer Camp Program will be sent out.
- June 1, 2011:** Early Bird Deadline - All Youth who pay their Summer Camp Fees in full by this date receive a \$20 DISCOUNT off their Regular Camp Fee.
- First Day of Camp Session:** A final Fee Settlement will take place at Camp. Be sure to bring a copy of all your payment records to this settlement, along with a method of payment for any fees still due. **YOU ARE RESPONSIBLE FOR ALL RESERVATIONS NOT PREVIOUSLY CANCELLED AT THE COUNCIL OFFICE.** (ie. If you reserve space for 20 boys and only 19 end up coming, you are still responsible to pay for the extra boy, unless changes are made to your reservation as described above.)
- First Day of Camp Session:** 2012 Campsite Reservations begin!
- Payments:** When making payments for Summer Camp by check, please use a single check when you make a payment. Multiple checks are harder to track and can slow the system down. All deposits are applied to a general Unit Summer Camp account. **It is up to the unit to track the payments of individual youth/adults.**
- Cancellations:** Cancellations made prior to June 1, 2011 receive a refund (minus the \$100 Camp Installment). No refunds are available after June 1, 2011.
